PROPOSED CHANGES TO BYLAWS OF THE HS/HSV BRANCH OF AAUW

The following are proposed changes to our <u>Bylaws of the AAUW Hot</u> <u>Springs/Hot Springs Village Branch</u>. These changes were discussed and approved by the board. They more accurately reflect our current committee structure, and allow for more member involvement on committees.

Our current Bylaws state that the Bylaws "may be amended by a twothirds vote of those present and voting at a general membership meeting provided written notice shall have been given to every member at least two weeks prior to the meeting." **This serves as your written notice.** The vote will take place at the February 18, 2015 meeting. Stated first is the current language; following is the proposed change in italics and underlined.

ARTICLE XII. COMMITTEES

Section 1. Standing committees shall be bylaws, college/university, diversity, Educational Foundation, fund raising, Legal Advocacy Fund, program, membership, public policy, and scholarship.

Section 1. Standing committees shall include Bylaws, College/University Relations, AAUW Funds, Fundraising, Public Policy, and Scholarship.

Section 2. Standing committees shall be appointed for a one-year term jointly by the president and president elect.

Section 2. Standing committees are appointed for a one year term by president in consultation with the president elect and committee chair. Standing committees with nine or more members, i.e., scholarship and fundraising, will have staggered three year terms.
